

#### SERVICE CONNECTED DISABILITIES

Disability Compensation is a tax free monetary benefit paid to Veterans with disabilities that are the result of a disease, injury incurred or aggravated during active military service. Compensation may also be paid for post-service disabilities that are considered secondary to disabilities occurring in service and for disabilities presumed to be related to circumstances of military service, even though they may arise after service. Veterans in the following categories may be considered for service connection for specific disabilities:

> Prisoners of War-Radiation Exposure Agent Orange Exposure-Gulf War Veterans Camp Lejeune Water Contamination

Veterans diagnosed with Amyotrophic Lateral Sclerosis (ALS) may be eligible for Service Connected Disability Compensation.

#### IMPROVED PENSION

Improved Pension is a tax free, income based benefit paid to wartime Veterans and surviving spouses or an unmarried child, who meets certain age or disability requirements and whose income for VA purposes and assets fall within certain limits.

Remarriage can affect eligibility of surviving spouse. In addition to the Improved Pension benefit the VA can pay an additional benefit to those who qualify for Aid and Attendance or Housebound benefits.

#### DEPENDENCY AND INDEMNITY COMPENSATION

Dependency and Indemnity Compensation (DIC) is a tax free, benefit paid to eligible survivors of military service members who died in the line of duty, eligible survivors of Veterans whose death resulted from a servicerelated disability or were rate 100% P&T for 10 consecutive years.

Remarriage could affect eligibility.

ChampVA and Dependents Educational Assistance (Chapter 35) are additional benefits.

#### **EDUCATION**

Vocational Rehabilitation-designed to help Veterans with service connected disabilities become suitably employed, maintain employment, or achieve independence in daily living.

#### **HEALTH BENEFITS**

The VA provides healthcare through an annual enrollment system. This system is based on 8 categories to ensure health care is available to all enrolled Veterans. Many Veterans **may** qualify for cost-free health care services based on compensable service connected disabilities.

VA Health Benefits includes all the necessary inpatient hospital care and outpatient services to promote, preserve, or restore your health. VHA medical facilities provide a wide range of services including traditional hospital-based services such as surgery, critical care, mental health, orthopedics, pharmacy, radiology optometry, audiology, and physical therapy.

#### **BURIAL BENEFIT**

VA burial allowances are partial reimbursements of an eligible Veteran's burial and funeral costs. When the cause of death is

not service related, the reimbursements are generally described as two payments: a burial and funeral expense allowance, and a plot or interment allowance.

A single payment is made when the cause of death is service-related.

Headstones and Markers furnished upon request, at no charge. A government headstone or marker for the unmarked grave of any deceased eligible Veteran in any cemetery.

**Home Loans**- Help Veterans purchase a home at a competitive interest rate often without requiring a down payment or private mortgage insurance.

Interest Rate Reduction Refinance Loan- Can help Veterans obtain a lower interest rate by refinancing their existing VA loan

Adapt Housing Grants- Help Veterans with a permanent and total service connected disability purchase or build an adapted home or to modify an existing home to account for their disability.
