ORDER EFFECTING INTERCHANGE OF
PENDING DIVISION III CASES TO DIVISION I

This matter comes before the Court *sua sponte*. The Honorable L. Marie Williams will retire effective January 3, 2024, creating a vacancy in the judicial seat of Division III of the Hamilton County Circuit Court until such time as her successor is sworn in (the "Succession Date"). After discussion with the other Circuit Court Judges, the Court finds it in the interests of justice and judicial economy that all cases pending in Division III requiring the Court's attention prior to the Succession Date be heard by another Circuit Court Judge via interchange.

It is therefore **ORDERED** that, effective January 3, 2024, the Honorable J.B. Bennett, Hamilton County Circuit Court Division I, shall preside by interchange over all cases identified in the attached Exhibit A until the Succession Date, after which point such cases will revert to the new Judge in Division III unless otherwise ordered.
