A RESOLUTION ACCEPTING THE PROPOSALS OF THE COUNCIL FOR ALCOHOL AND DRUG ABUSE SERVICES, INC. dba CADAS, INC., HELEN ROSS McNABB CENTER, INC., AND PARKRIDGE VALLEY HOSPITAL FOR RESIDENTIAL DRUG COURT TREATMENT SERVICES AND AUTHORIZING THE COUNTY MAYOR TO SIGN ANY CONTRACTS NECESSARY TO IMPLEMENT THIS RESOLUTION.

WHEREAS, proposals were received in response to public advertisement for a one (1) year contract, with the option to renew for four (4) additional one (1) year periods, subject to an annual review of client services, to provide treatment services for the Hamilton County Drug Court Program; and,

WHEREAS, the program will offer a sentencing alternative for certain selected offenders; and,

WHEREAS, the Council for Alcohol and Drug Abuse Services, Inc. dba CADAS, Inc., Helen Ross McNabb Center, Inc., and Parkridge Valley Hospital were selected to provide various services requested in the proposal; and,

WHEREAS, these treatment services are totally funded by the Hamilton County Drug Court Program State Grant (2014-15) Tennessee Certified Recovery Court Program.

NOW, THEREFORE, BE IT RESOLVED BY THIS COUNTY LEGISLATIVE BODY IN SESSION ASSEMBLED:

That the proposals of the Council for Alcohol and Drug Abuse Services, Inc. dba CADAS, Inc., Helen Ross McNabb Center, Inc., and Parkridge Valley Hospital to provide Residential Drug Court Treatment Services for the Hamilton County Drug Court Program are hereby accepted, and authorizing the County Mayor to sign any contracts necessary to implement this resolution.

**Decision and Rationale for the RFP
Residential Drug Court Treatment Program
RFP#0914-029**

Three proposals were received in response to the RFP #0914-029 for the Residential Drug Court Treatment Program for Hamilton County Drug Court. The three proposals were reviewed for compliance with the requirement set forth in the RFP document. This is a one (1) year contract, with the option to renew for four (4) additional one (1) year terms, subject to an annual review of client services, to provide the services outlined in the proposal.

We recommend accepting the proposals from CADAS, Inc., Helen Ross McNabb Center, Inc., and Parkridge Valley Hospital utilizing the specific services and pricing schedule as listed below.

- The proposal from CADAS, Inc. is recommended for all the services requested in the proposal including Detoxifications, Residential Services, Half-way Housing, Intensive Out-patient Services and Relapse Prevention Group Sessions.
- The proposal from Helen Ross McNabb Center, Inc. is recommended for Half-way Housing, Intensive Out-patient Services and the Relapse Prevention Group Sessions.
- Parkridge Valley Hospital is recommended for Intensive Out-patient Services.

Awarding these services to multiple service providers will increase the outreach and flexibility of this program for the Hamilton County Drug Court.
