A RESOLUTION APPOINTING AN INDIVIDUAL TO THE TENNESSEE GENERAL ASSEMBLY, REPRESENTING THE 30TH LEGISLATIVE DISTRICT, TO SERVE FROM SEPTEMBER 10, 2014, UNTIL THE CERTIFICATION OF THE NOVEMBER, 2014 TENNESSEE GENERAL ELECTION.

WHEREAS, Vince Dean has represented the 30th Legislative District in the Tennessee General Assembly; was elected in the August 7, 2014 Hamilton County General Election to the position of Hamilton County Criminal Court Clerk for a term beginning September 1, 2014, and ending August 31, 2018; and has submitted his resignation from the Tennessee General Assembly, effective as of August 31, 2014; and

WHEREAS, Tennessee Code Annotated Section 5-1-104 requires this county legislative body to appoint an individual to serve in said legislative capacity until the results of the November, 2014 Tennessee General Elections are certified, wherein an election to fill said position is on the ballot; and

WHEREAS, this county legislative body has provided both the members of this county legislative body and the citizens of this county with the notice of its intent to fill said vacant position as required by Tennessee Code Annotated Sections 5-5-113 and 5-5-114, respectively.

NOW, THEREFORE, BE IT RESOLVED BY THIS COUNTY LEGISLATIVE BODY IN SESSION ASSEMBLED:

That _____ is hereby appointed to the Tennessee General Assembly, representing the 30th Legislative District, for a term commencing September 10, 2014, and ending upon the certification of the State of Tennessee General

Election (to be held in November, 2014), wherein the voters of said District will elect their representative to serve in said capacity.

BE IT FURTHER RESOLVED THAT THIS RESOLUTION TAKE EFFECT FROM AND AFTER ITS PASSAGE, THE PUBLIC WELFARE REQUIRING IT.
