Mayor Coppinger spoke about the recent flooding throughout the county and the work that is being done to combat the flooded areas. He asked Chris Adams, Director of Emergency Management, to provide additional information.

Mr. Adams stated eight houses on Hunter Road still have water around them that will not drain. He reported certain agencies, including the Baptist Association and Red Cross, are providing help. He added the department is applying for a mitigation grant that could help those with frequent flooding problems.

In response to Commissioner Geter's question, Mr. Adams stated the grant could provide 100 percent for purchase of the property if the property has been flooded six or more times. He noted the grant application will come before Commissioners soon.

Mayor Coppinger made comments in reference to the ongoing issues with the new sewage treatment plant. He explained how a recent community meeting came together in which some Commissioners were not made aware.

Commissioner Bankston accepted responsibility for those not made aware of the meeting.

In response to Commissioner Sharpe's question, Dean Moorehouse, residing at 8114 Mahan Gap Road, addressed Commissioners regarding a community committee he developed at the direction of Mayor Coppinger. It was noted Mr. Moorehouse spoke out heavily in opposition of the Mahan Gap Road location. Mr. Moorehouse explained the committee is comprised of Mr. Moorehouse and community volunteer Brent Smith, two engineers, an attorney, a builder, and a marketing specialist. He stated the committee has developed search criteria to identify sites and has been in contact with Mike Patrick, interim Executive Director of the Water and Wastewater Treatment Authority. Mr. Moorehouse explained several reasons why the Mahan Gap Road site was not a suitable location and noted that another location has been identified that

meets many of their criteria. He indicated the 156-acre site has 75 cleared acres, few neighbors, and is next to the lake, which would require less sewage pipe line. The exact location was not identified due to potential community impact.

Mr. Moorehouse reported the committee is working on putting together a final report to present to Commissioners.

In response to Commissioner Martin's question, Mr. Moorehouse reported the identified site has 646 residents within a two mile radius; none of those residents are on the committee. It was noted Commissioner Bankston is part of the committee as well.

Commissioner Martin questioned whether the county had relied so heavily on a community committee in the past for major decisions. Mayor Coppinger stated community input has always played a major role in decision-making.

Commissioner Boyd requested a copy of the search criteria from Mr. Moorehouse.

Mayor Coppinger echoed earlier comments about the importance of community input. He stated WWTA board members are committed to working with the community to identify the best and most cost efficient site. He voiced encouragement by Mr.

Moorehouse's report; however, he reminded Commissioners that any site other than the original Mahan Gap Road location is going to require additional funding.

Commissioner Fairbanks emphasized the committee is providing recommendations and providing community input but will not be making any final decisions.

Commissioner Fairbanks recognized several members of the Sheriff's

Department including Director of Support Services Geno Bennett, Chief Deputy Austin

Garrett, and Information Systems Manager Ron Bernard.

Commissioner Bankston emphasized the community committee would be bringing a recommendation to the Commission for approval.

In response to Chairman Smedley's question, Mayor Coppinger stated WWTA officials are currently in Atlanta meeting with the Environmental Protection Agency (EPA). He stated he would try to get a report from the meeting.

Chairman Smedley congratulated East Hamilton junior Madison Hayes for winning the Class AAA Miss Basketball award.
