Present and presiding was the Honorable Sabrena Smedley, Chairman. County Clerk Bill Knowles called the roll of the County Commission and the following, constituting a quorum, answered to their names: Commissioner Baker, Commissioner Bankston, Commissioner Fairbanks, Commissioner Geter, Commissioner Mackey, Commissioner Martin, Commissioner Sharpe, and Chairman Smedley. Commissioner Boyd arrived after the roll call. Total present – 9. Total absent -0.

Also in attendance were County Mayor Jim Coppinger, members of his administrative staff, County Attorney Rheubin Taylor, and County Auditor Jenneth Randall.

Chairman Smedley introduced Judi Bell, First Church of Christ, Scientist, who gave the invocation. Commissioner Fairbanks led in the pledge to the flag.

RESOLUTION NO. 319-27 A RESOLUTION AUTHORIZING DISCUSSIONS
BETWEEN MEMBERS OF THIS COUNTY LEGISLATIVE BODY AND MEMBERS OF

WASTEWATER TREATMENT WITHIN THE HAMILTON COUNTY REGION.

ON MOTION of Commissioner Bankston, seconded by Commissioner Mackey, to adopt Resolution No. 319-27.

Commissioner Bankston stated this Resolution would allow the county to join with the city in a cost/benefit analysis of combining the City of Chattanooga Moccasin Bend sewage operation with the Hamilton County Water and Wastewater Treatment Authority (WWTA). He asked Dean Moorhouse, who has been leading the community search committee to identify potential treatment plant locations, to come forward to present the committee's full recommendation.

Mr. Moorhouse reported the committee evaluated 17 total sites using WWTA search criteria and later narrowed that to five sites. He explained after studying impacts on property value, and environmental and health concerns the committee determined continuing to utilize the Moccasin Bend facility would be as much as \$6.3 million a year cheaper than building a new sewage treatment plant. He added the committee also found that building storage tanks and installing sewer lines to connect to the Moccasin Bend plant are practical alternatives to finding a site for a new plant. He also presented

a breakdown of all potential costs and savings. A copy of the presentation was filed in the Clerk's office.

In response to Commissioner Martin's question, Commissioner Bankston confirmed the purpose of this item is to open a channel for discussion with the city about the cost/benefit of consolidation. Commissioner Martin encouraged Commissioners to stay in their lane and voiced concerns of not having adequate time to review the Resolution.

21:00

ON MOTION of Commissioner Martin, seconded by Commissioner Boyd, to defer Resolution No. 319-27 to the April 3rd Regular Meeting.

21:57

Commissioner Baker stated he felt as though he was given adequate time to review this item.

23:28

In response to Commissioner Boyd's question, Mayor Coppinger confirmed although he made the suggestion he was not part of forming the community search committee.

24:22

Commissioner Boyd voiced strong disapproval of this Resolution and any efforts that would result in consolidation with the city sewer system and noted having the city in control of economic growth in the county was concerning. He criticized the search

committee for the lack of transparency, taking issue with many of the details and statistics presented using slang to characterize the report given by Mr. Moorhouse. He also emphatically disagreed with an option identified by the search committee to reopen a decommissioned sewage treatment plant in East Ridge behind the hospital on Spring Creek Road. He read a letter into the record from East Ridge City Mayor Brian Williams and Assistant City Manager Kenny Custer that outlined several reasons why East Ridge would not be a viable location to rebuild or rehabilitate a sewage plant. A copy of the letter was filed in the Clerk's office.

Commissioner Sharpe reported this item condemns the state voucher bill, which provides vouchers for use by families to send their children to non-public schools if they are not satisfied with the public school system. He cautioned that allowing such vouchers could harm public education and lead to a potential abuse of education funds. He encouraged Commissioners to take immediate action, as the legislation on education savings accounts is moving through the Legislature quickly. It was noted the School Board earlier voted 7-1 to oppose the legislation. Commissioner Sharpe asked that the Resolution be amended to replace 'Governor Bill Lee' with 'House Bill 939'.

ON MOTION of Commissioner Martin, seconded by Commissioner Boyd, to defer Resolution No. 319-26.

The foregoing Motion to defer Resolution No. 319-26 was rejected on a Roll Call vote, with the following members of the County Commission being present and voting as follows: Commissioner Baker, "Aye", Commissioner Bankston, "Nay", Commissioner Boyd, "Aye", Commissioner Fairbanks, "Nay", Commissioner Geter, "Nay",
