Present and presiding was the Honorable Chester Bankston, Chairman. County Clerk Bill Knowles called the roll of the County Commission and the following, constituting a quorum, answered to their names: Commissioner Beck, Commissioner Boyd, Commissioner Fields, Commissioner Graham, Commissioner Mackey, Commissioner Martin, Commissioner Smedley, and Chairman Bankston. Commissioner Fairbanks was absent. Total present - 8. Total absent – 0.

Also in attendance were County Mayor Jim Coppinger, members of his administrative staff, County Attorney Rheubin Taylor, and County Auditor Jenneth Randall.

0:29 PRESENTATION – CERTIFICATE OF CONGRATULATIONS – HIXSON HIGH SCHOOL JUNIOR RESERVE OFFICERS TRAINING CORPS (JROTC)

Commissioner Martin presented the Hixson High School JROTC members with a Certificate of Congratulations for winning first place in the Hamilton County Drill Competition. He invited the students and their instructor, Master Sergeant John Burhans, to come to the podium. Commissioner Martin reported he had the honor to speak to the students at the Hixson High School Military Ball this year, and noted they will be marching in the 2017 Armed Forces Day Parade on May 5<sup>th</sup>.

Master Sergeant Burhans commended the hard work and dedication of the students. He noted this is their second year as Hamilton County Drill Competition champions. At this time, a round of applause was given.

Commissioner Martin distributed certificates to each member of the JROTC team. He congratulated the students on their success.

Commissioner Boyd spoke regarding this item, which approves the expenditure of \$5,000.00 from discretionary bond funds as allotted to District 8 to assist in purchasing band/orchestra instruments for Chattanooga School for the Liberal Arts. It was noted the funds are bond funds from fiscal year 2015.

#### **COMMITTEE OF THE WHOLE – RESOLUTION NO. 517-7**

Assessor of Property Marty Haynes spoke regarding this item, which approves an upgrade to the computer-assisted mass appraisal (CAMA) software from Patriot Properties, Inc. for the Assessor of Property's office in the amount of \$85,000, plus the required annual licensing and support fees. It was noted the request comes out of the

current year's operating budget. Assessor Haynes stated the upgrade to the software will enable the appraisal process to operate more efficiently.

In response to Commissioner Boyd's question, Assessor Haynes reported per the initial contract (*Resolution No. 910-31*) with Patriot Properties, Inc. states the annual licensing and support fees total \$69,000.00.

In response to Commissioner Fields' question, Assessor Haynes clarified the \$85,000.00 for the upgrade comes from savings in the current year's budget.

Commissioner Fields commended Assessor Haynes for the savings.

Assessor Haynes distributed a handout detailing several benefits the software upgrade will enable. A copy of the handout was filed in the Clerk's office.

Director of General Services Lee Norris spoke regarding this item, which authorizes an application to the Tennessee Department of Transportation and acceptance of a Litter Prevention and Trash Collection Grant in the amount of \$127,100.00, with a contract period beginning July 1, 2017 and ending June 30, 2018. was noted this is an annual grant from the state that assists with the Community Corrections Litter Grant Program for litter collection on public highways.

Sam Mairs, Juvenile Court Administrator, spoke regarding this item, which authorizes a contract between the State of Tennessee Department of Human Services and the Hamilton County Juvenile Court Title IV-D Child Support Division. It was noted the total amount of the State's liability is \$352,798.00 with a County match of \$181,745.00 from the fiscal year 2017 budget, which has not yet been approved.

In response to Commissioner Fields' question, Mr. Mairs clarified that while the fiscal year 2017 budget has not been approved, the state requires the contract to be signed prior to July 1<sup>st</sup>. It was noted the contract can be amended once the budget is adopted.

Don Gorman, Director of Administration for the Sheriff's Department, spoke regarding this Resolution, which approves the purchase of an upgrade to the Law Records Management and Mobile Law Workstation software, support, and maintenance contract from TriTech Software Systems for the Sheriff's Office. The contract is for a one period beginning August 7, 2017 and ending August 6, 2018 and amounts to \$284,322.96.

In response to Commissioner Graham's question, Mr. Gorman stated the upgrades will allow the Sheriff's Office to become more independent. It was noted the funds were budgeted in the current year's operating budget.

Commissioner Fields announced the Armed Forces Day Parade will take place next Friday, May 5<sup>th</sup> at 10:30 AM.

Commissioner Graham reminded members of the Commission and audience about the Lookout Valley Neighborhood Association Golf Tournament this Saturday at Trenton Golf Club at 8:30 AM.

Commissioner Graham reported he has recently spoken with several different legislators regarding Commission pay. He reminded everyone that Commissioner's pay is directly tied to the pay of the County Mayor, and over the last several years some Commissioners have requested the law to be changed. He stated the issue continues to surface and expressed his support for putting the issue on the ballot in the next election and allowing the voters to decide what percentage the commission should be paid.

Commissioner Martin publicly thanked Volkswagen for their partnership with the State of Tennessee to provide a \$1 million investment in Volkswagen eLabs in eight Hamilton County schools. The labs will provide students access to emergent

technologies that will better educate and prepare the future workforce in the fields of engineering and technology. It was noted the eight schools were announced at a press conference on Tuesday.

Commissioner Martin invited everyone to attend a steak dinner at Hixson High School on Sunday from 12:00 to 4:00 PM to raise funds for the wrestling team.

Commissioner Boyd echoed Commissioner Martin's comments regarding the Volkswagen eLabs. He reminded Commissioners the funds for the labs are public funds that were a part of their incentive package.

Commissioner Smedley recognized Christy Gibson in the audience at today's meeting. Ms. Gibson is the new Director of Governmental Affairs for the Greater Chattanooga Association of Realtors. It was noted Robert Nodes previously held the position.

Commissioner Smedley announced the next joint meeting with the School Board has not been scheduled as School Board members are currently focusing their attention on selecting a new Superintendent.

Commissioner Smedley also thanked Volkswagen for their eLab investment. She added East Hamilton Middle School was one of the eight chosen schools to receive one of the labs.

Commissioner Smedley responded to the comments regarding Commissioner's pay and stated that a majority of Commissioners do not run for office based on compensation, but instead to make a positive impact on the community.
