Commissioner Haynes, Chairman of the Zoning Committee, stated that without objection the Zoning Committee recommended that Resolution No. 816-31 and 816-32 be delayed until the September 14<sup>th</sup> Agenda Session, to be voted on at the September 21<sup>st</sup> Regular Meeting. He explained that the request to delay was due to the pending results of a traffic study by the developer.

Commissioner Haynes provided details regarding Resolution No. 816-33, and stated that the Zoning Committee reviewed and recommended approval. He noted that another portion of Scoggins Circle was abandoned in 2012 (per Resolution No. 1212-12B, adopted on December 19, 2012).

**ON MOTION** of Commissioner Haynes, seconded by Commissioner Smedley, to adopt Resolution No. 816-33.

In response to Commissioner Graham's question, Administrator of Public Works and County Engineer Todd Leamon stated that the Engineering Department reviewed the Resolution and gave a recommendation to deny. He stated that an apartment complex uses a gated entrance located on Scoggins Circle for a secondary entrance into the complex. It was noted that the Engineering Department does not recommend approving the abandonment of any road that provides a public benefit.

In response to Commissioner Fields question, Mr. Leamon clarified that it was the position of the Engineering Department that the road should not be abandoned. He stated that the Resolution was to approve the abandonment of the 10 feet of Scoggins Circle, a County owned road, adjacent to a gated access to the apartment complex. He further explained that if the road is abandoned, the apartment complex will no longer have that option for egress from the facility.

In response to Commissioner Mackey's question, Mr. Leamon confirmed that an affirmative vote would be in favor of abandoning 10 feet of Scoggins Circle. He added that the road provides a public benefit as a secondary entrance into the apartment complex; a main entrance is located on Ooltewah-Georgetown Road.

Commissioner Haynes reported that the applicants are suffering property damage by those using the road as an entrance into the apartment complex.

Attorney Taylor clarified that a "yes" vote would be in favor of granting the abandonment of the road.

Commissioner Haynes distributed for the record copies of his letter of resignation from the Board of Commissioners indicating the effective date, Thursday, August 31, 2016, pending certification of the election that was held on August 4<sup>th</sup>. A copy of the letter was filed with the Clerk's office.

23:41

Commissioner Graham announced that on September 10<sup>th</sup>, the Lookout Valley
Lions Club will be holding its annual golf tournament at the Trenton Golf Club. He
reported that 100% of the proceeds are used to provide food, toys, and gifts for children
and families at Christmas. He stated that Commissioner Fields will also be participating

in the golf tournament. It was noted that Commissioner Graham has been a board member for the Lookout Valley Lions Club for many years.

Commissioner Graham also spoke about the District 3 Commission seat vacancy, and stated that the Commission should appoint an interim to serve until the November election to represent the 37,000 residents of District 3. He expressed his concerns of potential issues it could cause to leave the seat vacant until the election. He added that if the Commission begins the process immediately, they could have a caretaker who agrees not to run for the position in place soon.

Commissioner Fairbanks stated that the Commission should defer to Commissioner Haynes regarding filling the District 3 Commission seat.

No action was taken on appointing an interim Commissioner.

### **DELEGATIONS**

Chairman Bankston asked for delegations on matters other than zoning.

Eric Alexander Atkins, residing at 2705 Riverside Drive Chattanooga, TN 37406, addressed the Commission as a representative of the Chattanooga-Hamilton County NAACP. He spoke about the state of the criminal justice system, and the current focus

of punishment and retribution as opposed to restorative justice. He emphasized the importance of complying with the United States Constitution, and having open discussions regarding criminal justice reform. He stated that the NAACP was displeased with the Commission's August 3, 2016 approval of Resolution No. 816-11, which approved establishing a victim's assistance assessment of \$45.00 against those found guilty of certain criminal offenses, and submitted a public dissent regarding the Commission action.

Mr. Atkins cited several examples of racial disparity in the criminal justice system, and asked for the Commission's cooperation in having an open discussion regarding criminal justice reform in Hamilton County. He noted that too many walls of inequality and injustice exist that need to be broken down, and when this happens positive changes will occur.

In response to Commissioner Mackey's question, Mr. Atkins stated that the Chattanooga-Hamilton County NAACP will hold a public forum to discuss criminal justice reform. Commissioner Mackey requested an invitation to the public forum.

Commissioner Beck thanked Mr. Atkins for his presentation and stated that he agreed with Mr. Atkins' comments about having a discussion regarding criminal justice reform in Hamilton County.

Mr. Atkins reported that 95% of those incarcerated are serving time for non-violent offenses, and that 40% of those are suffering from some type of mental illness. He stressed the importance of addressing mental health in the community. He noted that it was a collective responsibility of the entire community to initiate change.

Commissioner Mackey reported that focusing on rehabilitation rather than incarceration could alleviate some of the burden on Hamilton County taxpayers.

Mr. Atkins once again emphasized the importance of using the Constitution as a guiding principle in criminal justice.

There being no further business, Chairman Bankston declared the meeting in recess until Wednesday. August 31, 2016 at 9:30 AM.
