Present and presiding was the Honorable Chester Bankston, Chairman. County Clerk Bill Knowles called the roll of the County Commission and the following, constituting a quorum, answered to their names: Commissioner Beck, Commissioner Boyd, Commissioner Fairbanks, Commissioner Fields, Commissioner Graham, Commissioner Haynes, Commissioner Mackey, Commissioner Smedley, and Chairman Bankston. Total present - 9. Total absent – 0.

Also in attendance were County Mayor Jim Coppinger, members of his administrative staff, and County Attorney Rheubin Taylor.

In honor of Veterans Day, Chairman Bankston asked that all of the veterans present at today's meeting stand. He thanked them for their service, and they were given a round of applause.

#### **COMMITTEE ASSIGNMENTS**

Chairman Bankston indicated the upcoming agenda items would be considered as follows:

- A Quarterly Investment Report for quarter ending September 2015 would be submitted for the record.
- An Order of Designation to the Planning Commission would be submitted as a matter of record.
- Unaudited Financial Reports from Circuit Court Clerk, Clerk and Master, County Clerk and Register for the fiscal year ending June 30, 2015 would be submitted as a matter of record.
- Resolution No. 1115-16 was the usual County Clerk item regarding notaries, etc. This required no committee assignment.
- Resolution Nos. 1115-17A, 1115-17B, and 1115-18 were assigned to the Zoning Committee, chaired by Commissioner Haynes.
- Resolution Nos. 1115-19, and 1115-25 through 1115-33 were assigned to the Finance Committee, chaired by Commissioner Boyd.
- Resolution No. 1115-24 was assigned to the Roads Committee, chaired by Commissioner Haynes.
- Resolution Nos. 1115-20 through 1115-23 and 1115-34 were heard by a Committee of the Whole.

Chairman Bankston stated that Resolution Nos. 1115-20 through 1115-23 and 1115-34 would now be heard by the Committee of the Whole.

### 1:44 COMMITTEE OF THE WHOLE – RESOLUTION NO. 1115-20

Commissioner Mackey spoke regarding this item, which appropriates \$1,500.00 from general fund discretionary monies to the City of Chattanooga as allotted to District 4. The funds will assist with renovations at the South Chattanooga Youth and Family Development Center. Commissioner Mackey added that this is an effort to help reduce violence.

There were no questions from Commissioners.

### 2:24 COMMITTEE OF THE WHOLE – RESOLUTION NO. 1115-21

Commissioner Mackey spoke regarding this item, which appropriates \$2,500.00 from general fund discretionary monies to the Tides Foundation as allotted to District 4. The NAACP has entered into an agreement with the Tides Foundation to create the NAACP Collective Action Fund in order to raise funds locally. It was noted that these funds will assist the NAACP in developing community initiatives and projects.

Commissioner Mackey added that the goal is to keep kids focused on education and out of trouble.

### 2:52 COMMITTEE OF THE WHOLE – RESOLUTION NO. 1115-22

Commissioner Beck spoke regarding this item, which appropriates \$2,500.00 from general fund discretionary monies to the Tides Foundation as allotted to District 5. He noted that this item is a joint effort with Commissioner Mackey in order to assist the NAACP in developing community initiatives and projects.

There were no questions from Commissioners.

#### **COMMITTEE OF THE WHOLE – RESOLUTION NO. 1115-23**

Attorney Taylor spoke regarding this item, which amends and extends the current contract with the Tennessee Valley Railroad Museum (TVRM) for management of the rail yard and tracks at the Enterprise South Industrial Park. The amended contract will guarantee the County at least \$140,000 in income per year for the TVRM's exclusive operation of the rail system inside the park.

In response to Commissioner Boyd's question, Albert Kiser, Administrator of Finance, added that the rail system has generated between \$76,000 and \$126,000 in revenue for the County over the last few years. He added that the amended contract will guarantee the County \$140,000 or 4% of their gross revenue, whichever is greater. Mr.

Kiser clarified that the County is not currently paying the TVRM to manage the rail system; their revenue is generated from suppliers through user fees. It was noted that the museum is required to report their gross revenue quarterly, and the County can audit those records if necessary.

In response to Commissioner Boyd's question, Tim Andrews, Director of the Railroad Authority, noted that he did not expect an employment increase in that department. Mr. Kiser clarified that there is clause within the agreement that would allow either party to break the contract if that became necessary.

Commissioner Haynes clarified for the record that the TVRM is a customer of his at Porter Warner Industries. He asked that Attorney Taylor advise him on whether he should recuse himself from the vote at next week's meeting. Attorney Taylor indicated there was not a conflict.

Mayor Coppinger noted that Attorney Allen McCallie was present at the meeting representing the TVRM.

In response to Commissioner Graham's comments, Attorney Taylor clarified that the County is guaranteed at least \$140,000 per year. It was noted that the County will not be responsible for any maintenance costs at the rail yard.
