3. The remaining 1:30 pm docket of in-person contested matters shall be called and heard in the order they appear on the docket below. Matters will NOT be placed to the heels.

4. To avoid congestion in the courtroom, if your Motion begins on page 5 or later, please contact the Court's Judicial Clerk (Karrie Davis at 423-209-6620) and provide your cell number. She will text you as your turn for argument approaches (approximately 10 minutes prior to being called).

5. As provided in the Plan of the 11th Judicial District, your failure to contact the Court, or your failure to appear in a timely manner, may result in your Motion being stricken, granted, or passed at the Court's discretion.
