Review of Hamilton County's "Real Estate" lease agreements

Recently, we reviewed the current real estate lease agreements in which Hamilton County is the Lessor and collects a lease payment. Our office examined six lease agreements: the Air Pollution Control Bureau, Parker Towing Company, Inc., Signal One, LLC, the US Department of Agriculture, Tennessee Valley Railroad Museum (TVRM), and Volkswagen Group of America, Inc. The respective lease payments received for FY22 were valid and in compliance with the lease agreements between Hamilton County and each Lessee. However, during the review, we found a conflict of interest that needs to be addressed.

OBSERVATION:

As a Hamilton County employee, Mr. Tim Andrews is Director of the Hamilton County Railroad Authority and is responsible for managing and overseeing the TVRM lease agreement. In addition, Tim Andrews is currently serving as the President of the Tennessee Valley Railroad Museum. Due to his direct involvement in the Lessee's organization, it is our opinion that there is a conflict of interest regarding the management of the lease agreement.

AUDITOR'S RECOMMENDATION:

We recommend transferring the management and oversight of the Tennessee Valley Railroad Museum lease agreement from Tim Andrews to the Real Property Office under the Public Works Division.

RESPONSE – PUBLIC WORKS DIVISION:

We concur with the auditor's recommendation and Real Property will begin management and oversight of the TVRM lease agreement.
