Review of Professional Services - Hamilton County Health Department

On August 4, 1993, Resolution No. 893-13 adopted a list of professional, technical and consultant services to be obtained based upon competency, integrity and skill. Hamilton County Procurement Rules, Section 3.3.10 "Designated Professional Services" state that "these contracts, regardless of the price, are not required to be awarded on the basis of a competitive sealed bid or competitive sealed proposal...." Although these services do not require a bid, procurement rule thresholds must still be followed.

Hamilton County Procurement Rules, Section 3.20, state "all awards from authorized purchasing methods of \$25,000 or greater will be presented by Resolution to the Board of Commissioners..." Procurement Rules, Section 2.4.2, state "all contracts and/or contract renewals in excess of \$25,000 or more shall only be executed by the County Mayor."

During our recent audit work on professional services expenditures, we expanded our tests of all departments to determine whether any professional expenditures greater than the \$25,000 annual threshold failed to be approved by resolution.

We identified one vendor for professional services within the Hamilton County Health Department who exceeded the purchasing threshold of \$25,000 (see **Appendix I**), which had not been approved by resolution nor the contract executed by the County Mayor. As of this date, no other county government departments were found to be in violation of purchasing threshold requirements for professional services.

AUDITOR'S CONCLUSION:

In compliance with Hamilton County Procurement Rules, the Hamilton County Health Department has properly submitted a resolution for approval to the Board of Commissioners along with the affiliated contract for execution by the County Mayor for services on behalf of Yogini H. Patel.
